Investment Policy – updated to 9 February 2015

MSH holds all surplus cash in short term deposits at banks approved by the Trustees and makes no investments in any other financial investments or derivatives such as equities, bonds, loans or options. All surplus cash is held in the functional currency of the MSH affiliate and not in foreign currencies.
